The Board reviewed the Agenda for the meeting, following which Directors Johnson, Luoma, Paschal, Morgan and Shafer confirmed that they have no conflicts of interest in connection with any of the matters listed on the Agenda.

Agenda: Mr. Beckman distributed for the Board's review and approval a proposed Agenda for the District's Regular Meeting.

Following discussion, upon motion duly made by Director Johnson, seconded by Director Morgan and, upon vote, unanimously carried, the Agenda was approved, as presented.

Following review and discussion, upon motion duly made by Director Johnson, seconded by Director Shafer and, upon vote, unanimously carried, the Board accepted the unaudited financial statements.

Manager's Report: Mr. Beckman reviewed the report with the Board, attached hereto and incorporated herein by this reference.

Additional Dwelling Units: Mr. Beckman discussed tap fees with the Board. Mr. Willis and Mr. Beckman advised the Board that Denver Water is allowing service lines (for ADU) to be tapped into the primary service lines. Mr. Willis advised the Board that it is preferable to have policies that align with service providers like Denver Water and Metro Wastewater. Mr. Beckman noted that he will work on a formal policy for the board to consider along with the 2023 Fee Resolution.

The Board discussed the option of requiring the City of Lakewood to connect to the sewer rather than to share wastewater indefinitely. The Board directed Mr. Willis to notify the City that the District will require a tap fee.
