The Board reviewed the Agenda for the meeting, following which Directors Johnson, Paschal, Morgan and Shafer confirmed that they have no conflicts of interest in connection with any of the matters listed on the Agenda.

Agenda: Mr. Beckman distributed for the Board's review and approval a proposed Agenda for the District's Regular Meeting.

Following discussion, upon motion duly made by Director Johnson, seconded by Director Morgan and, upon vote, unanimously carried, the Agenda was approved, as presented.

Following discussion and review, upon motion duly made by Director Shafer, seconded by Director Paschal and, upon vote, unanimously carried, the Board ratified the payment of accounts payable as presented.

<u>Financial Statements</u>: The Board reviewed the unaudited financial statements of the District for the period ending September 30, 2023.

Following review and discussion, upon motion duly made by Director Shafer, seconded by Director Luoma and, upon vote, unanimously carried, the Board accepted the unaudited financial statements.

2024 Rate Increase Memorandum from Denver Water: Mr. Beckman reviewed with the Board. He noted that a rate increase of 5% is expected for 2024.

2024 Draft Budget: Mr. Beckman reviewed the 2024 Draft Budget with the Board.

<u>Certification of Delinquent Accounts</u>: Director Johnson opened the public hearing on the Certification of Delinquent Accounts for Jefferson County. No interested party appeared before the Board to object to the certification of their account for collection. There being no comment from the public, either inperson or in writing, the public hearing was closed.

Following discussion and review, upon a motion duly made by Director Johnson, seconded by Director Morgan and, upon vote unanimously carried, the Board approved Resolutions 2023-10-1 to Certify Delinquent Accounts for collection by the Jefferson County Treasurer.
